1. Mr. Simpson moved on behalf of the committee:

to approve the list of preferred alternatives as final recommendations for Amendment 11. The list includes preferred alternatives for all but two topics (interim measures for transition period to limited entry and incidental catch). The list also includes three clarifications related to stacking provisions and one addition related to the length of time vessels should have to apply for a limited entry permit.

Clarifications:

- Section 3.1.2.5.4 (permit stacking) is for limited access general category qualifiers only these alternatives would not apply to limited access vessels who may also qualify for a general category permit. Those vessels would not be permitted to stack limited access general category permits on a vessel that is limited access already.
- Clarify language of stacking alternatives to be that stacking could be permanent or on an annual basis and that a vessel could only lease/sell their entire allocation not a portion of their allocation.
- When a vessel wants to permanently stack a general category limited entry permit they also must either transfer all of their federal limited access permits or permanently cancel such permits.

Additions:

• NMFS consider a 90-day requirement for vessels to apply for a limited entry permit once amendment 11 is effective.

1a. Mr. Stockwell moved to amend and Mr. Salisbury seconded: to revise Section 3.1.4.3 in the main committee motion to read: to establish a NGOM management area north of 42°20'. The area will be open to vessels holding a general category permit on the control date. Vessels will be permitted to possess or land up to 200 lbs. per trip with a maximum of 10.5-foot dredge width with no vessel upgrade restrictions as defined in Section 3.1.2.5.2.2. The area would be under a hard TAC set by the scallop PDT based on federal portion of scallop resource in the NGOM. All federal permit holder landings from the NGOM count toward NGOM TAC. If a vessel qualifies for a limited access general category permit under Amendment 11, any landings from the NGOM will count against their individual allocation as well as the NGOM TAC. Vessels must have VMS. Once the TAC is reached, there will be no fishing in the NGOM by any federal scallop vessels.

1b. Mr. Rice moved and Ms. Kurkul seconded:

to move the question.

The motion to move the question **carried** on a show of hands (14/1/0).

1c. The motion to amend was voted:

to revise Section 3.1.4.3 in the main committee motion to read:

to establish a NGOM management area north of 42°20'. The area will be open to vessels holding a general category permit on the control date. Vessels will be permitted to possess or land up to 200 lbs. per trip with a maximum of 10.5-foot dredge width with no vessel upgrade restrictions as defined in Section 3.1.2.5.2.2. The area would be under a hard TAC set by the scallop PDT based on federal portion of scallop resource in the NGOM. All federal permit holder landings from the NGOM count toward NGOM TAC. If a vessel qualifies for a limited access general category permit under Amendment 11, any landings from the NGOM will count against their individual allocation as well as the NGOM TAC. Vessels must have VMS. Once the TAC is reached, there will be no fishing in the NGOM by any federal scallop vessels.

The motion to amend **carried** on a show of hands (13/3/1).

1d. Ms. Valliere moved to amend and Dr. Pierce seconded: to revise Section 3.1.2.2.3 qualification time period to March 1, 2000 – November 1, 2004 (5-year alternative)

The motion to amend **carried** on a show of hands (16/1/0).

1e. Mr. Goethel moved to amend and Mr. Leary seconded: to adopt Section 3.1.8.2 on establishing a new permit category on incidental catch.

The motion to amend **carried** on a show of hands (16/1/0).

1f. Mr. Simpson moved to amend and Mr. Rice seconded: to amend the NGOM alternative to include: any vessel permitted to fish for scallop post Amendment 11 and also fishing under a limited access multispecies or monkfish permit would be exempt from the dredge restriction in the NGOM.

The motion to amend **carried** on a show of hands (14/0/0).

- 1g. Mr. Simpson moved to amend and Mr. Salisbury seconded: that the Council recommend allocations be rounded to 10 lbs, include a section in Amendment 11 that identifies the need for a cost recovery program, identify the vessel baseline provision (as of the date of Amendment 11 implementation), add a section that either the stacking provision or maximum percentage ownership restriction limit ownership (whichever is more restrictive), and set the maximum ownership to 60,000 lbs. Lastly, add the alternative that restricts a sector allocation to 20%.
- 1h. Mr. Odlin moved to amend the amended motion and Ms. Kurkul seconded: to eliminate the 60,000 lb. cap and go with a straight percentage.

The motion to amend **carried** unanimously on a show of hands.

1i. Mr. Odlin moved to amend the amended motion and Mr. Leary seconded: to eliminate vessel upgrade restrictions.

The motion to amend **carried** on a show of hands (9/7/0).

1j. Mr. Odlin moved to amend the amended motion and Mr. Salisbury seconded: to eliminate the 20% cap and allow sectors to be formed.

The motion to amend **failed** on a show of hands (3/13/1).

1k. Mr. Goethel moved to amend the amended motion and Ms. McGee seconded: if permits are temporarily stacked for a year, then all other limited access permits that vessel has are stacked for the year.

that the Council recommend several clarifications:

- allocations be rounded to 10 lbs.
- include a section in Amendment 11 that identifies the need for a cost recovery program
- add the alternative that restricts a sector allocation to 20%
- eliminate the vessel upgrade restrictions alternative
- related to ownership restrictions, an individual cannot have ownership interest in more than 5% of the general category allocation, and the general category vessel cannot have more than 2% of the total general category allocation on one platform
- a maximum possession limit of 400 lbs
- allow revision of the possession limit as a frameworkable item for sectors

Clarifications:

- Section 3.1.2.5.4 (permit stacking) is for limited access general category qualifiers only these alternatives would not apply to limited access vessels who may also qualify for a general category permit. Those vessels would not be permitted to stack limited access general category permits on a vessel that is limited access already.
- Clarify language of stacking alternatives to be that stacking could be permanent or on an annual basis and that a vessel could only lease/sell their entire allocation not a portion of their allocation.
- When a vessel wants to permanently stack a general category limited entry permit they also must either transfer all of their federal limited access permits or permanently cancel such permits.

Additions:

NMFS consider a 90-day requirement for vessels to apply for a limited entry permit once Amendment 11 is effective.

Additional clarifications recommended by the Council:

- allocations be rounded to 10 lbs.
- include a section in Amendment 11 that identifies the need for a cost recovery program
- all sector participants be restricted to a maximum possession limit of 400 lbs. and to allow revision of the possession limit as a frameworkable item for sectors
