

Gear Requirements:

Escape Vent

Must be located in the parlor section of the trap.

Ghost Panel

Must be located in the parlor section of the trap and cover an opening of at least 3-3/4" square and be attached with a biodegradable fastener.

Trap size

Near shore management areas are not to exceed <u>25,245 cubic</u> inches in volume.


Offshore management areas are not to exceed <u>30,100 cubic</u> inches in volume.

Trap ID

A tag with an identifying number assigned by the Regional Administrator; or positive identification marking is required by the vessel's home-port state. TRAP TAGS MUST IDENTIFY MANAGEMENT AREA LISTED ON PERMIT.

Mutilated Definition:

Lobsters must have an intact and measurable body and tail. Lobsters that have lost one or both claws are not mutilated.


Standard V-Notch Definitions:

A Female American lobster bearing "any notch or indentation at least as deep as 1/8-inch, with or without setal hairs", in the flipper next to and to the right of the center flipper as viewed from the rear of the lobster (underside of the lobster down and tail toward the viewer), or any female American lobster that is mutilated in a manner that could hide or obliterate such a mark.


