- 2. The Committee needs to determine which measures to further develop for the next monkfish action. The Monkfish Committee has been working on Amendment 6 since 2010. Amendment 6 was intended to implement catch shares (sectors or an ITQ) in the monkfish fishery. However, it has been modified to include DAS and landing limit measures and a monkfish DAS leasing program.
- 3. Other issues have been raised by industry, including reducing latent effort, restricting vessels to 1 area, integrating skates into the Monkfish FMP, and revising the RSA program, among others. The Committee may choose to develop these measures in the next monkfish action.
- 4. The Committee may wish to develop recommendations for Council priorities 2015. The draft priorities are enclosed.
