- 2. Framework 48 is not complete and will not be ready for a final vote at the November Council meeting. A special Council meeting has been scheduled for December 20, 2012.
- 3. While we do not need to make final decisions on FW 48, we will need to make a recommendation on allocations of GB and SNE/MA yellowtail flounder to the scallop fishery so that Scallop Framework 24 can be moved forward. While not as critical, the Committee may also

want to make a decision for the allocation of SNE/MA windowpane flounder to the scallop fishery. We may also want to make a Committee recommendation on the timing of access to the GB scallop access areas – Scallop Framework 24 is a joint groundfish/scallop action that will consider modifying the dates.

- 4. The Committee may wish to develop recommendation for Council priorities for 2013. The draft priorities are enclosed.
- 5. The Groundfish Advisory Panel recommended the Council pursue several mitigation measures for 2013. The Committee will need to decide whether to forward those recommendations to the full Council for action. The GAP report includes recommendations for the following:
  - Emergency action to allow the landing of barndoor skates in the Northeast skate wing fishery.
  - Emergency action to eliminate the monkfish trip limit in the NFMA for limited access vessels fishing under a groundfish DAS under sector management rules.
