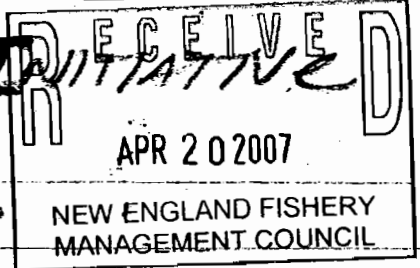


# SUSTAINABLE FISHOMES INITIATIVE VINEYARD SECTOR PLAN



Whereas, there are no longer any commercial quantities of groundfish within these waters, and that government management has not succeeded in its efforts for fifteen years, we of the Vineyard seek local control of our waters to effect a restoration.

This restoration effort will join Science and Fisheries and be funded by discards retained by two Vineyard vessels, both in federal and STATE WATERS.

### Principles of Sustainability

- ✓ what is good for the fish is good for the fishermen
- ✓ all sea life and components thereof are precious to the ecosystem as a whole
- ✓ fishing efforts must not be negative to the living environment that creates the fish.
- ✓ equality of access based on daily pounds per man - catch rate not to exceed regenerative capacity.

✓ In cases of depletion of particular valuable specie of historic and intrinsic worth beyond dollars A FISHERIES Emergency is auto-matic-ly declared. Extraction of dollars ceases until fishes are restored.

★ The plan for restoration to begin immediately upon approval by NOAA, NMFS, DMF, Comm. of MASS., WHOI, MBL, U.N.H. and Sustainable Fisheries Initiative, in partnership with the towns and fishing communities that still exist and can remember on Martha's Vineyard.

★ "Remember the cod? (with his whisker)"  
The plan is a phased in, two stage conversion and development of two possible codfish hatching, grow out and release scenarios involving the in-harbor waters of the towns and alongshore sites. Initially, fry to come from Great Bay Aquaculture and be grown progressively larger as we move to investigate feasibility of doing

Dear Council Members.

As a Martha's Vineyard native son, I was always fascinated by stories told by local fishermen catching cod fish offshore using conventional rod and reel or tub trawling. In the early 1970s, I, too, had the opportunity to go codfishing. We would set long lines, go rod and reeling for three to four hours, then pull the trawl lines and head for home. For several years, this was very productive. Codfish up to thirty pounds filled the boat on a regular basis.

Not always so. One day we arrived at the fishing grounds only to find the large red balls marking gill net lines were everywhere. It was not long before our long lines no longer produced a profitable day - much less our rod and reels. The gill nets remained. Indiscriminately catching all species swimming by. Unattended during stormy weather the gill nets continued to kill, the catch unuseable and wasted. The arrival of the gill nets marked the beginning of the downward spiral of the cod..

I ask the Council to seriously consider the successful restoration which has resulted from Florida's ban on gill netting.

I personally feel that gill nets must be removed from the New England fishing grounds.



Dear Council Members,

The Vineyard had a very successful codfish winter fishery in the 1970's and 1980's. In the winter, all the lobsterboats, conkboats and scup and sea bass boats turned to codfish. We longlined and handlined for cod. The council decided to save the groundfish and directed the Boston and Gloucester gillnet boats to fish for dogfish. They came and set their nets south of the Vineyard where we traditionally fished for cod. They came in November when the dogfish were there and blanketed the area with gillnets and never left until May. They did this for several years. Now you can barely catch a cod to eat.

Prior to the time these gillnetters came, I set a couple of gillnets along with my cod longlines. On an overnight set with these nets, a third of the fish in these nets had to be discarded because the sandfleas ate them up so bad. After that, I threw the nets in the dump. I can't imagine the amount of fish these gillnetters must have wasted by leaving their nets out weeks on end, waiting for weather to tend them. It just defies common sense why the Council ever allowed this to happen, being a group trying to restore fish stocks. Those wasted fish didn't benefit anyone. Thank you for your time.

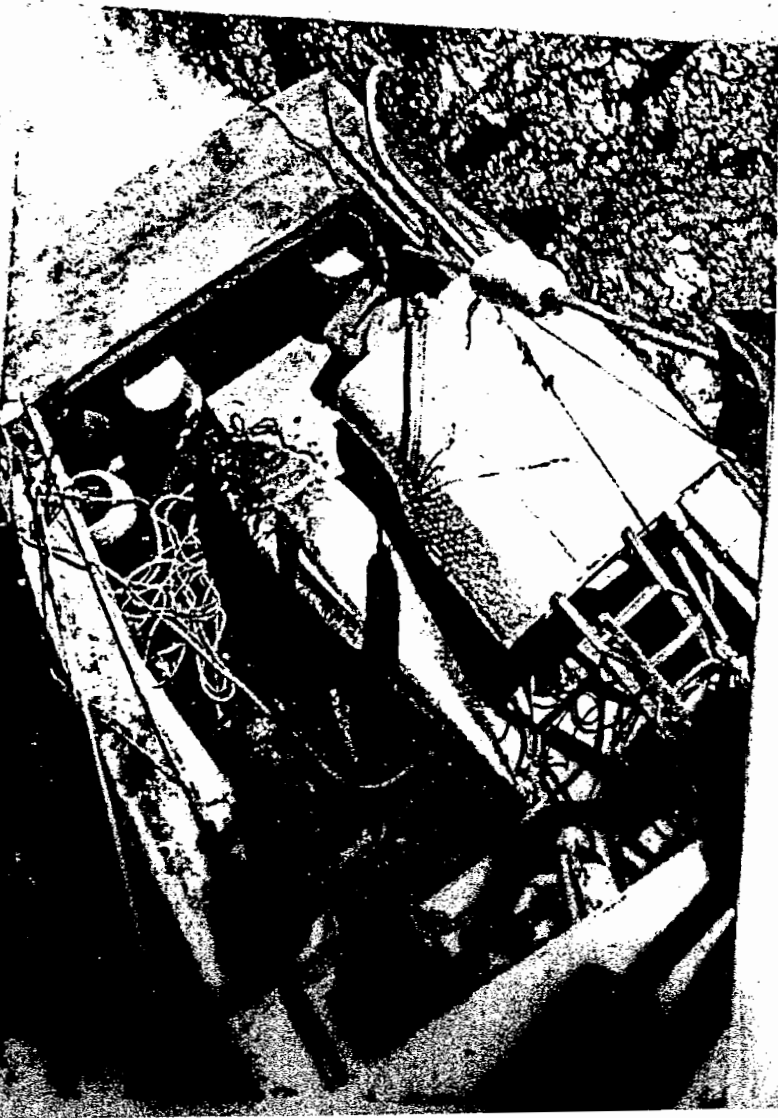

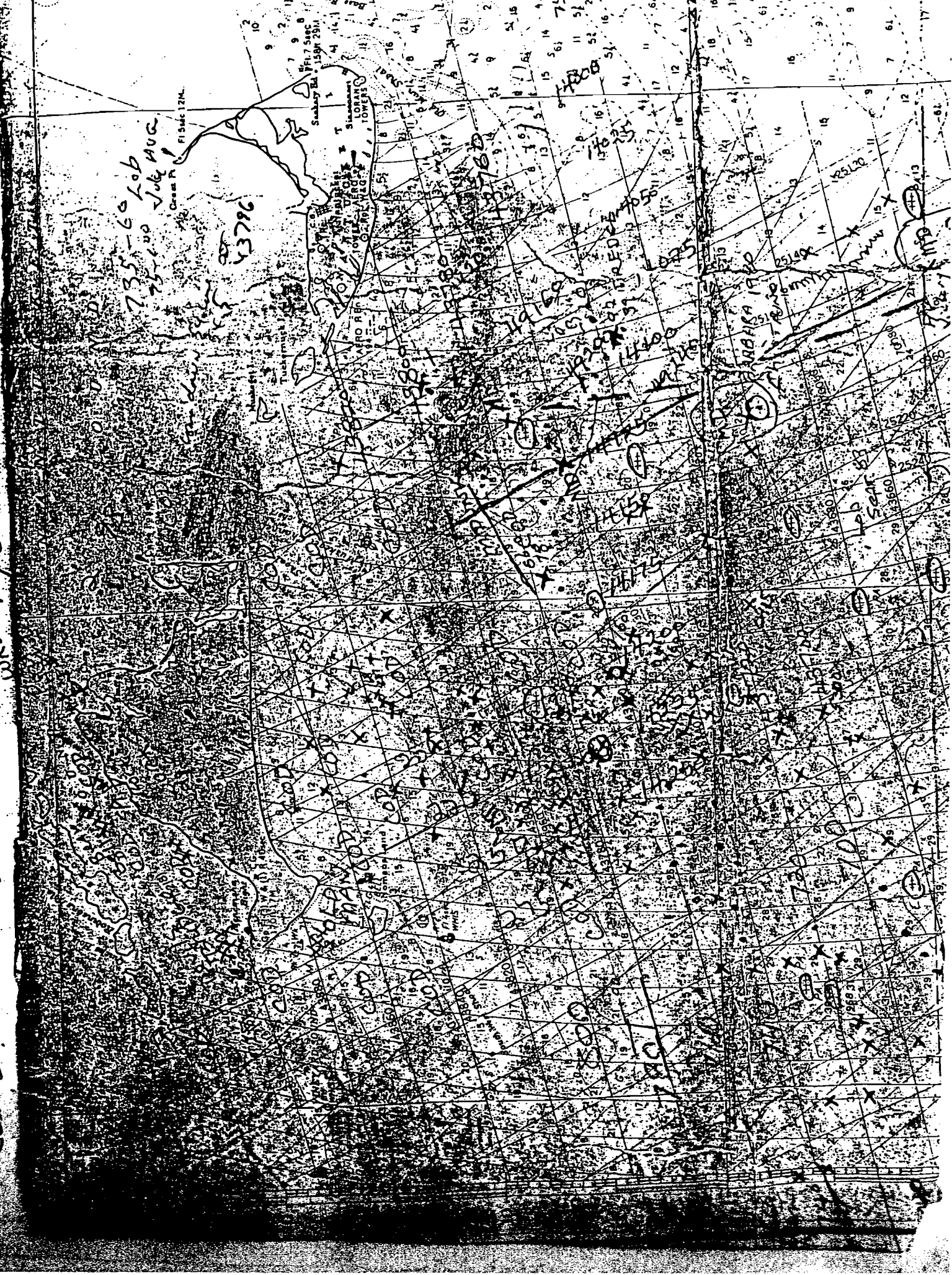

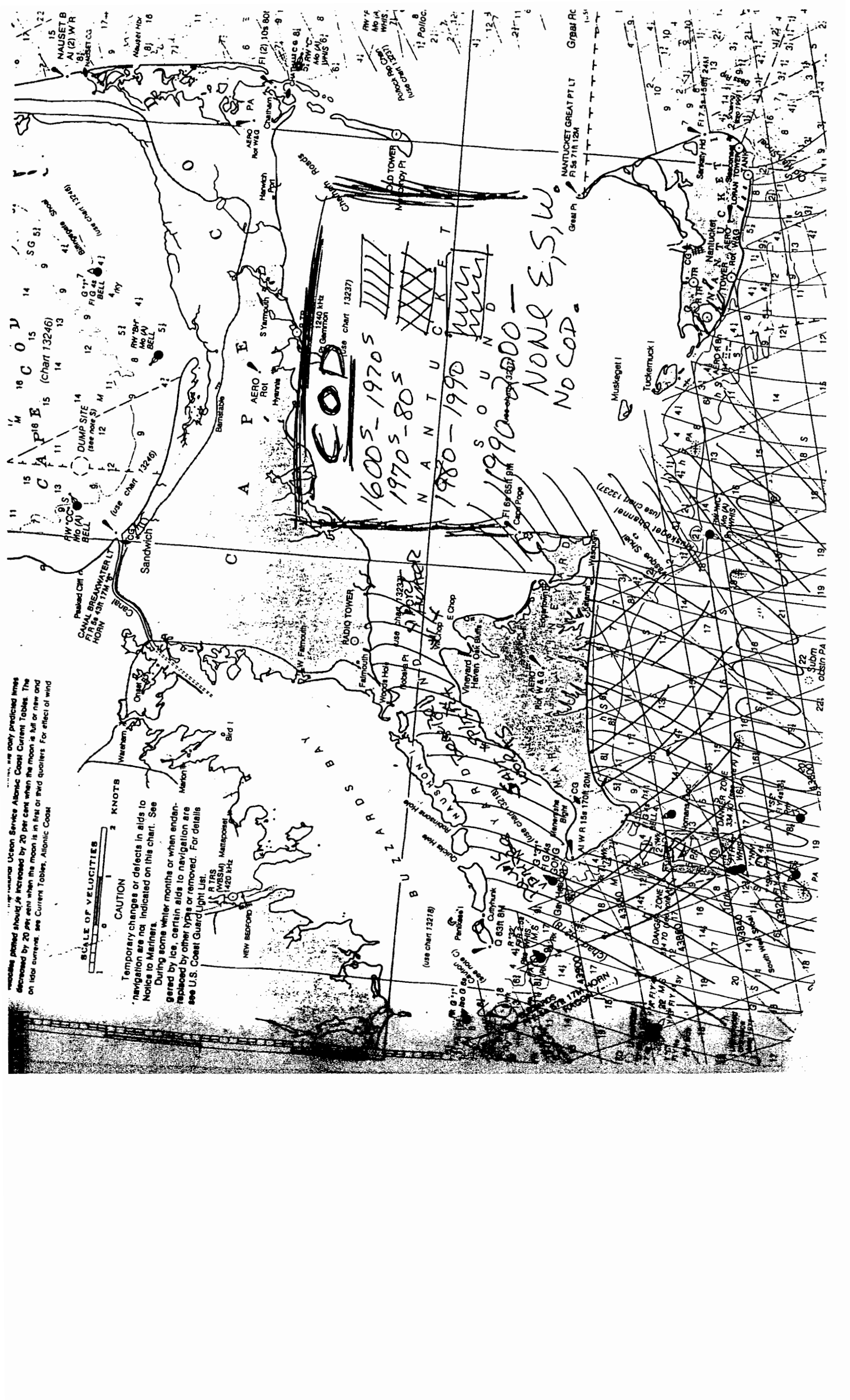

### IN Regulatory process

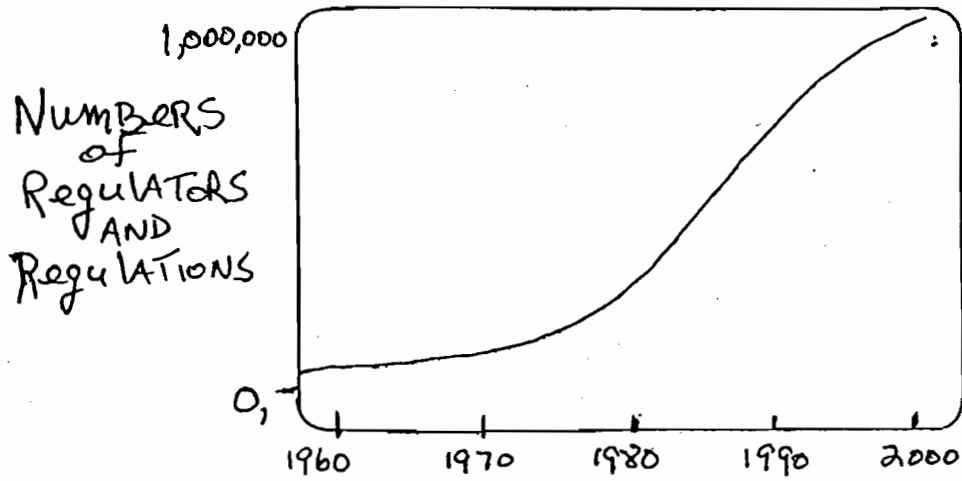
- 1) demoralized - <sup>our JOBS for winter gone</sup> Past experiences BAD

- 3) ISOLATION - live on an island
- 4) feel that huge discards are easily tolerated on large boats.  
BIG Boats unaccountable for discards.

### Causes for OPTIMISM —

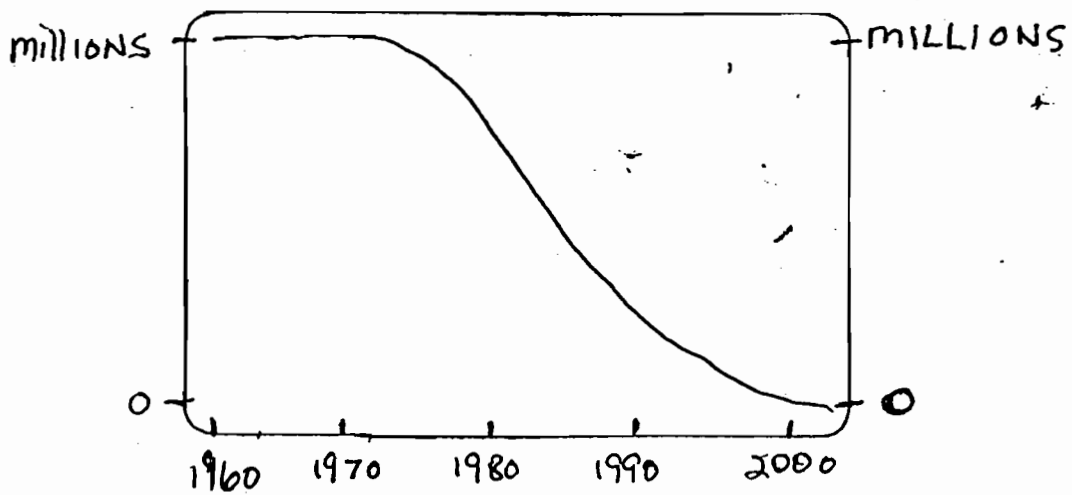
- 1) FISH WANT to reproduce
- 2) Cheap cod (frozen) available from ALASKA, Iceland makes remaining cod in local waters more valuable if left alive and able to reproduce.
- 3) from period of collapse onward is prime chance to develop a fisheries plan BASED ON PRINCIPLES.
  - a) permit maximum spawning (size limits, closures)
  - b) eliminate discards in future (starting now)
  - c) Realize that men with mortgages make poor stewards of resource.

RE: FEDERAL NMFS Rule Change affecting Vineyard  
FOR CODFISH

Under Amendment #13 of the NMFS groundfish plan the qualifying years were established at 1996-2001.

At that time, I appeared at the NMFS groundfish subcommittee at the Biltmore Hotel in Providence, R.I. to <sup>TRAWL</sup> testify and plead that the Vineyard, ~~trawl~~ jig and handline fishermen could not qualify to get permits under this regime (and due to our long, pre Revolutionary association with codfish and our 350 year history of codfish export), and we deserved to be grandfathered. This meeting was chaired by Mr. Frank Blount of R.I. The subcommittee and grand council both approved to give us special status

Now, under the new Amendment 16 of the Groundfish Plan, the qualifying years are changing to 2000-05, more newer years in which no codfish have been accessible to Vineyard fisherman.

On April 12, 2007, I gave testimony and made a plea for maintaining special consideration i.e., the grandfather provision

giving us special status that will hopefully continue through the new amendment 16.

On Friday, April 20, the Vineyard will get to present its case to the NMFS ~~MULTI~~ SPECIES (Groundfish) Oversight Committee

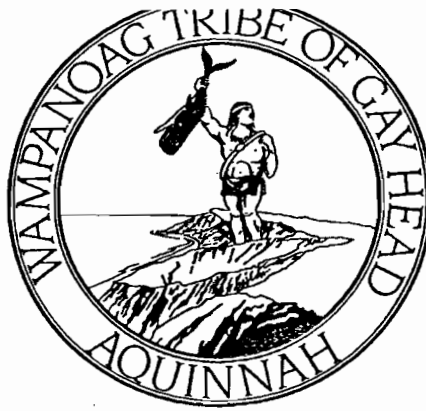


