## Agenda:

The Groundfish Oversight Committee will meet to discuss several issues related to the Northeast Multispecies Fishery Management Plan. The Committee will:

- Receive reports from the Groundfish and Recreational Advisory Panels
- Discuss possible adjustments to sector management measures. The Committee will continue to develop options to improve sector monitoring, including both at-sea and dockside monitoring. They may discuss different funding mechanisms, appropriate coverage levels, and full retention of allocated groundfish species.
- Discuss issues related to setting Acceptable Biological Catches (ABCs), Annual Catch Limits (ACLs), and Accountability Measures (AMs). With respect to ABCs/ACLs/AMs, the Committee will consider additional sub-ACLs for the scallop fishery for stocks such as SNE/MAB windowpane flounder and SNE/MA winter flounder. As directed in the letter from the National Marine Fisheries Service approving Framework 47, Committee members will also discuss additional reactive AMs for wolffish, SNE/MA winter flounder, and Atlantic halibut.
- The Committee may begin a discussion of recreational fishing measures for FY 2013.
- Discuss other business, such as issues related to Georges Bank yellowtail flounder management.

Options identified by the Committee will be included in a future management action or actions that will be considered by the Council in the fall of 2012.

**Note:** If you are submitting written comments for consideration at this meeting, we must receive them by noon on Friday, May 25, 2012 (due to the Monday holiday).
