Research Steering Committee

I. STATUS

- A. Meetings: The Council's Research Steering Committee met on May 30, 2007 to conduct a management review of two final cooperative research reports that were submitted to the Northeast Consortium (NEC) and NOAA Fisheries Northeast Cooperative Research Partners Program (NCRPP) for funding. In addition, the committee discussed and/or developed recommendations concerning: a) the NCRPP-sponsored peer review of the pilot study fleet/electronic logbook project conducted by the Northeast Fisheries Science Center; b) data archiving and data access in the context of how cooperative research data is currently made available and requirements for researchers to provide access to data collected through federally-funded projects; c) the Northeast Science Center's report on the impacts of fishing on groundfish spawning activities; d) the research-related mandates in the Magnuson-Stevens Fishery Conservation and Management Act; and finally, e) the NCRPP's most recent activities.

The objective of the RSC's management review of final reports is to provide feedback to the Council, its oversight committees and Plan Development Teams on the applicability and use of project results in management decision-making. Recommendations concerning the other issues on the agenda are discussed in the meeting summary.

II. COUNCIL ACTION

- A. The Council should review the recommendations of the RSC concerning use of the final project results in a management context and consider other issues contained in the meeting summary and identified by the RSC Chairman. Several sets of recommendations are provided to the Council on a range of issues.
