and 2) measures to address unused 2013 Closed Area I access area trips.

The IFQ Report is not final and will not be presented to the Council at this time but Advisors will have the opportunity to provide initial feedback. Finally, the Advisory Panel will discuss possible priorities for scallop related actions for 2014 and make recommendations to the Scallop Committee for consideration.
