# **Herring Committee**

#### I. STATUS

## A. Meetings:

- The Herring Committee met on March 30-31, May 17, July 27-28, and September 1-2, 2010 to continue work on the development of management alternatives for consideration in Amendment 5 to the Atlantic Herring FMP (measures to establish a catch monitoring program, measures to address river herring bycatch, criteria for access to groundfish closed areas, measures to address interactions with the mackerel fishery, and measures to protect spawning fish).
- The Herring Advisory Panel met on August 25, 2010 to review the alternatives under consideration in Amendment 5 and provide recommendations to the Herring Committee.
- The Herring Plan Development Team (PDT) met on April 8, June 15, July 15, and August 19 to work on analyses to support the development of alternatives for consideration in Amendment 5.

## II. COUNCIL ACTION

- A. Herring Committee Motion: That we request that States continue and expand their portside sampling programs provided funds are found for the program, in support of the Council's priority for portside sampling coverage and that the Herring PDT and Technical Committee jointly meet to review the States shoreside monitoring programs in order to address the goals and objectives of Amendment 5
- B. **Herring Committee Motion:** That the Council prioritize a joint Groundfish/Herring Action (as part of Herring Amendment 5) to establish criteria for midwater trawl vessel access to the groundfish closed areas
- C. **Council Action:** Approval of management measures/alternatives for further development in a Draft Environmental Impact Statement for Amendment 5
