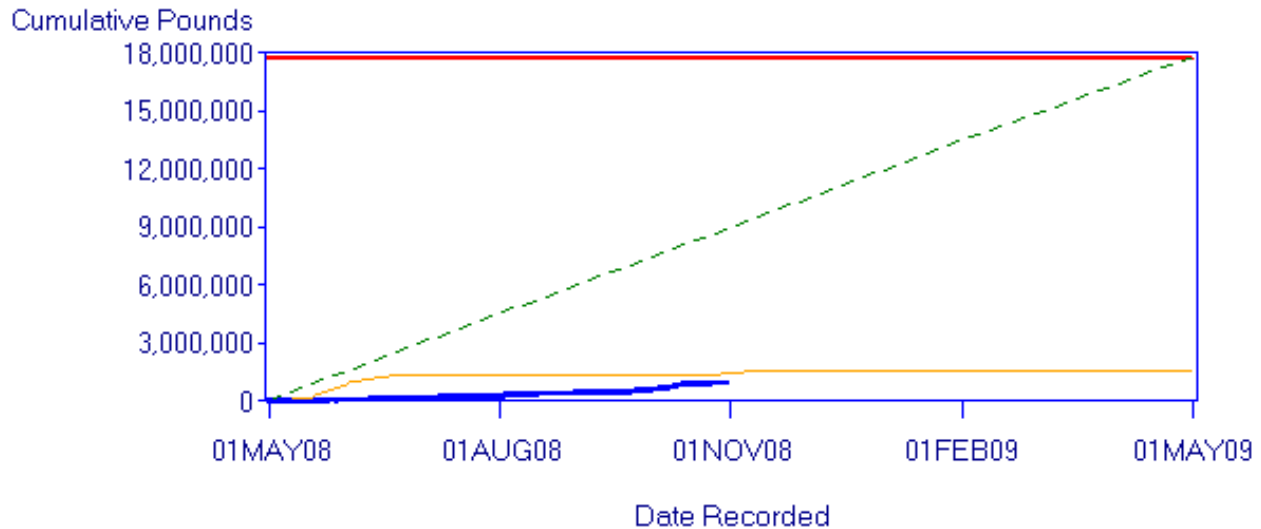

Based on 1st quarter FY2008 data, the ratio of dealer reported haddock landings to Vessel Monitoring System (VMS) reported haddock kept equals 0.95 for the non-trawl fishery. For the remainder of the fishing year, based on FY2007 data the ratio of dealer reported haddock landings to Vessel Monitoring System (VMS) reported haddock kept equals 1.21.
