#### **Ecosystems**

Move on behalf of the Ecosystem and Ocean Planning Committee that the Council adopts the 5 following short-term recommendations (from the December Workshop) as their priorities: #3 of Coordination - continue and expand these discussions (with workshop attendees and others not present) to include groups and issues not represented in our first Workshop #5 from Significant New Work - identify pilots for specific action using existing knowledge, staff, and funds

#14 of Significant New Work - participate with Restoration Center staff in regional prioritization efforts

#15 of Significant New Work - work with regional restoration center to develop funding proposals and projects of mutual interest

#31 of Significant New Work - NMFS habitat and stock assessment scientists should work with managers to initiate demonstration project.

## **HMS**

HMS sub-committee met to discuss options in the proposed Rule to Modify the Retention of Incidentally-Caught HMS Species in Atlantic Trawl Fisheries. As a result the Committee reached consensus on the following:

The Committee recommends to the full Council to support ISSUE A-Alternative A2. (Establish a new permit for *Illex* squid moratorium permit holders to retain up to 15 swordfish.) Preferred option

After reviewing Issue B - Incidental Catch of Smoothhound Sharks in all Atlantic Trawl Fisheries, the Committee reached consensus as follows.

- Support Alternative B2 - Allow for the retention of Smoothhound Sharks caught incidentally in trawl gear, in amount not to exceed 25% of the total catch, by weight, on board or offloaded from the vessel and explore a 5,000 trip limit as an alternative and as recommended by ASMFC. (Preferred Alternative)

### **Dogfish**

Move to recommend to the *Councils* that the following action alternatives be considered under the issues in Spiny Dogfish Amendment 3 and that the FMAT further analyze these alternatives:

- Under Research Set-Aside, include in the specification process an RSA provision of up to 3% of the annual TAL.
- Under Essential Fish Habitat, review and update as necessary EFH definitions and fishery impacts to EFH as required by MSA.
- Under Year-end Rollover of Mgmt. Measures, extend existing management measures into new fishing year until the measures specified for that year are implemented.
- Coastwide annual quota with no seasonal, geographic or other allocation, or regional and/or state allocation scheme as established by Addendum 3 by the ASMFC
- Under Limited Access, action alternatives for consideration:
- 1. Possible action alternatives to be developed by the FMAT, explore administrative solutions within the open access system and extent of spiny dogfish federal permit dropping, and
- 2. No action
