Subject: NEFSC Scallop Research Set-Aside Program Time Line

This responds to concerns and questions over the scallop Research Set-Aside program (RSA) expressed in a letter dated September 15, 2010. The New England Fishery Management Council requested time lines and posed questions about the 2010 scallop RSA grant awards and concerns over the timing and administration of this program. Programmatically, the four RSA programs created by both the New England and Mid-Atlantic Councils are challenging. Multiple RSA grant competitions are simultaneously conducted which have overlapping time lines. In response to the Council's questions, and in the interest of providing more transparency, a listing of dates when specific RSA grant administrative actions occurred during 2009-2010 is presented for all 4 RSA program in an attachment to this letter. This should help the Council to more fully understand challenges to the RSA administrative processes and when various actions occurred.

The Council recently adopted a number of actions to be included in Amendment 15 to the scallop FMP. We are optimistic that those actions will help improve the overall management of the scallop RSA program. These along with additional RSA programmatic modifications that the Northeast Fisheries Science Center will take should improve the processing time needed to award all RSA grants.

Specific questions posed by the NEFMC:

1. Question: Can NMFS explain the RSA timeline (2010 awards as an example) so the Council can better appreciate the constraints and necessary steps involved? If this timeline is more transparent the Council could potentially assist NMFS to identify areas that could be adjusted. What are the major stumbling blocks? Can they be addressed?

Answer: The RSAs are simply complicated grants that require a number of administrative and regulatory compliance steps needed to process and grant final awards. The process is depended on numerous offices and a many people to complete several reviews and administrative steps, all requiring time and coordination. The Council acknowledged this in its letter.



The 2010 scallop RSA program awarded eight grants. This is the largest number of grants in a single scallop RSA competition cycle in the programs history. In doing so, the entire scallop RSA quota was fully utilized for the first time ever. This required skillful and time consuming negotiations in order to fully utilize all scallop RSA quota to fully fund all eight proposals. After the negotiations were completed the principal investigators were then required to resubmit modified proposals and budgets resulting from negotiations. All proposals were then submitted to the Grants Management Division as a package for initial selection. The letters requesting proposal modifications were sent on May 10 to all PIs. The last revision was received on July 13. The 9-week delay from this resubmission consequently delayed the other 7 awards, as they must all be submitted as an initial award package together. The supplemental decision memorandum was then redrafted and the entire package was submitted to NOAA Grants Management Division (GMD) on July 17, 3 days later. The GMD then expedited the awards and they were all awarded on August 12.

The program office (NEFSC Grants and Acquisitions office) must conduct scientific and management reviews of all proposals. The management review is unique to RSA grants as the program's mission is to support fisheries management. Historically, the management review occurred after the scientific review was completed. This prolongs the final selection process and is unnecessary. This is one area where we may be able to improve. We suggest that the management review occur prior to or simultaneously to the scientific reviews. This could save up to several weeks leading up to the initial selection of projects for funding.

2. <u>Question</u>: Were there other priorities that shifted staff resources away from the Scallop RSA program this year?

Answer: The NEFSC RSA staff includes one Federal Program Officer (FPO) who is assigned full time to administer all RSA grant competitions, and an RSA program coordinator who also provides support to the Northeast Cooperative Research Program (NCRP). In fiscal years 2009 & 2010 an additional allocation of cooperative research funds (\$13 million) was provided to the Northeast Region by NOAA Leadership. The increased administrative actions and acquisitions temporarily placed additional workload on the cooperative research program staff. NEFSC staff adjustments are currently being implemented to address the need to more efficiently administer all cooperative research and RSA grant and contractual competitions. Also, the monkfish RSA program competition runs concurrently with the scallop RSA competition. The monkfish awards were prioritized early on in the 2010 competition cycle due to concerns and the need to facilitate monkfish compensation harvesting during favorable market conditions.

In 2010 the Atlantic scallop fishery management action (Framework 21) was not implemented until June 28. As a result, compensation fishing could not have occurred prior to that date. Scallop RSA grant awards could have been made using Special Award Conditions (SAC) allowing research grant activities to precede only after the conditions are satisfied. Special award conditions may include such things as completed regulatory compliance reviews (NEPA or ESA Section 7 consultations) or NOAA approval of specifications to FMP, which authorizes

RSA quota allocations. Though SACs are a convenient way to award RSA grants prior to all necessary grant requirements being in place, they do create additional steps and slow the process, therefore GMD encourages their use under limited circumstances.

The Council's Executive Committee expressed concern that scallop rotational area surveys that are entirely funded by RSA competitive grants are critical for the development of management scenarios. It is a risk to depend on competitive grant awards for such important survey information, particularly in setting harvest allocations for very high value fisheries such as the scallop fishery. The risks associated with competitive processes, such as being out competed and not being selected for funding based on technical scores or other RSA variables such as potentially low scallop prices and/or harvest rates, subject the surveys to unnecessary risk of no or insufficient funding. We are encouraged that the Council is exploring actions, as proposed in Amendment 15 that may mitigate this risk.

RSA staff has recommended some administrative or structural changes that may improve the programs' efficiency. Some of these include:

- Expand use of alternative acquisition methods including multi-year no-cost contract options, joint agreements, as well as currently used grants and cooperative agreements. This will provide more flexibility in funding longer-term projects and better conform to Federal acquisition laws.
- Create multi-year RSA research priorities and competitions resulting in longer-term projects. This will help streamline timing of RSA project awards relative to resource availability or fishing season and reduce administrative burden. We are delighted to see that a similar action was listed in the Amendment 15 modifications.
- As a result of the RSA programmatic review conducted in 2008-2009, the NEFSC is considering awarding 'no-cost' contract to a third party in order to conduct auctions to sell RSA quota and deposit the resulting funds into either a private account or the NOAA account created in the Fisheries Conservation and Management Fund (herein referred to as the Fund) created by NMFS through Congressional directive contained in the MSRA (P.L. 109-479, sec. 208 16 U.S. Code 1891b). Consideration of this alternative must be with the stipulation that the funds deposited into the Fund be provided solely to the program from which the funds originated. This may facilitate contractual acquisitions using funds rather than RSA quota. Annual audit of the RSA accounts would be conducted and posted on the Internet for public viewing through the no-cost contractual agreement with the third party. This would provide more transparency and facilitate analysis of all RSA programs from a financial and economic perspective.
- The NEFSC will consider alternative cooperative research models for some RSA priorities. The Council and NMFS may consider programs similar to the Consolidated Highly Migratory Species FMP implemented by the Southeast Science Center under 50 CFR part 635 (See Federal Register notices: 73 FR 40658, July 15, 2008). This could simplify the RSA process for the rotational surveys and minimize competitive risk.

The RSA staff will work harder to improve communications and coordination among Councils' staff, regulatory compliance offices and the RSA community. We will set strict deadlines for all reviews, shorten the time needed for drafting and approval of initial Decision Memoranda, and demand quicker responses from proposers in modifying their budgets and projects subsequent to

negotiations. We will strive to improve coordination and communications in completing regulatory analysis and compliance reviews. The 2010/2011 Scallop, Monkfish, Mid-Atlantic and the 2010 Herring RSA grant competition time lines are shown in attachment 1. We will be happy to meet with you to review the past two years RSA competitions and to further discuss potential changes to improve RSA programs.

This letter is related to the administration of the Scallop Research Set-Aside program (RSA). Concerns have been raised about the timing and administration of this program at recent public meetings. The New England Council's Executive Committee met this week and directed this letter be sent so the NEFMC can better understand what the potential constraints on the program may be.

As you know the Scallop RSA program is an integral reason why scallop area rotation and the FMP overall is so successful and effective. Dozens of projects have been funded over the years that have provided outstanding results that have directly improved management decisions about scallop biology and abundance, bycatch, EFH, and other topics. Despite all the successes, there are issues with the program.

The Council has been aware of these issues for several years, and that is why Amendment 15 to the Scallop FMP included measures designed to make the program more effective. Some of the measures under consideration could help with particular aspects of the program, but the major issues with the current program actually seem to be administrative and staff resource related — issues that cannot be addressed through a Council action.

Making awards in a timely fashion has always been a challenge for the program because of the multiple steps needed to award a federal grant. We recognize that there are numerous stages of review and legal approval that need to take place and getting that all done quickly is virtually impossible. For the last two years the Agency decided to send out announcements for funding earlier than usual to hopefully provide more time for review and approval of projects. Everyone hoped this would give more time for review and fix most of the timing issues – but it has not. Awards have been made later for the last two years than ever before, and the Council is concerned that the effectiveness of the program is being jeopardized.

Below is a summary of what seemed to occur this year. Staff has filled in dates that we are aware of, but I request that you provide any outstanding dates or correct any that are not accurate. If the RSA timeline is more transparent the Council will have a better understanding of what the constraints are and potentially help identify where major stumbling blocks are so that improvements can hopefully be made.

2010 RSA Timeline

2010 RSA announcement – July 16, 2009
Deadline for Applications – August 31, 2009
Review of proposals – 3 months or so?
Management Review Meeting – December 10, 2009
Selection of projects - April 2010?
Negotiations with selected projects - May 2010?
Negotiated final budgets due to NMFS – mid-May 2010
Final packages arrive at NOAA grants – mid-July 2010
Official awards made – mid-August 2010?
Process for any specific LOAs required—?
February 29, 2011 - deadline when all RSA compensation fishing must take place

While the timeline is not complete, it is clear that certain milestones are taking substantial amounts of time and the Council would like to know more about why that is happening. For example, is seems that the time between the Management Review meeting (December 2009) and the final selection of projects (April 2010) was four months. In addition, there seems to be a two month period between when final budgets were due to NMFS from researchers and when projects were sent to NOAA grants (mid-May 2010 to mid-July 2010). What are the primary reasons for these extended time periods? Are there any feasible ways to reduce them?

I also wanted to make a point about the 2011 Scallop RSA timeline. The 2011 RSA Funding Announcement was published on July 16, 2010 with a deadline of August 30, 2010. The Council supports having early announcements to provide for more review time, but in this case the 2011 announcement came out before 2010 final awards were made. This situation is difficult for researchers to apply for grants when the status of current grants is still unknown. Furthermore, it may be beneficial to make the deadline slightly later in the future, September sometime, so researchers can benefit from early PDT discussions about what likely management scenarios are for the future years (i.e. which access areas should be surveyed based on updated biomass projections).

Part of this situation could be that the RSA Program is not fully aware of the deadlines and management constraints placed on these awards. Typically, the PDT sets a deadline of August 1 for all scallop biomass survey results. Research takes place in the late spring or early summer and results must be available for the PDT by August 1. This provides several weeks for the PDT to combine all the surveys, review the results, and present ABC recommendations to the SSC by late August. This timing is critical so that there is time to develop management scenarios and analyses for the framework action in September and October before final action in November. If survey data are not available before August 1 the "up-to-date" biomass surveys the Council has come to depend on may no longer be feasible under the current system.

In addition, it is critical that awards are made earlier in the year because there are other constraints on the vessels that participate in research in terms of when and where they can harvest compensation fishing. The most obvious example is the 2 month seasonal closure in the ETA and Delmarva to protect sea turtles. No compensation fishing can occur during September and October when the area is closed – so if awards are not made well before these closures vessels have to wait until November and only have until the end of February to complete their fishing. Winter months are not ideal for fishing because scallop meat weights are less and weather conditions are less favorable.

In summary, the results of Scallop RSA projects are essential for "real-time" management of rotational areas; research has to be conducted well before the Council needs the results (August 1); and there are other management constraints the RSA review team should be aware of in terms of when compensation fishing can actually take place. Please explain the current RSA timeline and let us know if there are specific resource constraints and/or conflicting priorities that may be hampering the effectiveness of the Scallop RSA program. The Council is aware that the timely administration of the Scallop RSA program is a great challenge. I look forward to working with you to address these issues because this program is critical for the continued success of the scallop management program and fishery.
