I. STATUS

- A. <u>Meetings</u>: The Scientific and Statistical Committee (SSC) met on August 10-11, 2009 and again on September 16, 2009 to accomplish the following:
 - <u>Groundfish</u> Finalize acceptable biological catches (ABCs) for fishing years 2010-2012 following a review of the Groundfish Plan Development Team's calculations of ABCs, incorporating previous guidance from the SSC;
 - <u>Sea Scallops</u> Finalize an ABC recommendation for fishing year 2010 following discussion of updated quantitative analyses of uncertainty associated with OFL;
 - **Herring** Review the available information provided by the Herring Plan Development Team and develop an ABC recommendation for the 2010-2012 fishing years, as well as an ABC control rule;
 - Red Crab Review the available information provided by the Red Crab Plan Development Team and develop an ABC recommendation for the 2010 fishing year, as well as an ABC control rule for future years;
 - <u>Skate Complex</u> correct the 2010-2011 skate complex ABC to be included in Amendment 3 to the Skate FMP (the recalculation will include the 2008 spring survey values for little skate); and
 - **EBFM Workshop** Review the follow-up activities necessary to develop a white paper outlining possible steps to promote progress toward EBFM planning

A report on the SSC's recommendations will be presented to the Council on Wednesday, September 23 by SSC member Dr. Pat Sullivan.
